• Development of Statewide Employment Related goals as corollary to education goals to increase high school graduation.

Chanda Cook: If this true partnership, graduation from high school and having them career ready goes hand in hand. wCx has increased work experience through Job 5000 campaign. What is the goal to ensure that all of our youth are ready for the workforce and become a constructive member of society?

Ken LoBene: wCx overall goal is to increase the graduation rate. But there are also sub goals such as: connected to school, meaningful work experience and reconnect them to school if they are not. The idea is that the best stimulus package is high school graduation and be prepared for college and the workforce. Every organization involved with youth activities should have the same goal, increase the high school graduation rate and meaningful work experience. This way the youth can see the picture that better jobs comes with education. The ultimate goal is to keep them in the path to graduation.

Chanda: Creating or having this discussion is part of the goals of RFL. If the overall goal is to graduate from high school, college ready and workforce ready then the Youth Council statewide strategic plan includes a corollary to education and workforce readiness. The question is how do we get other state agencies to align with the goals of the Governor’s Youth Council?

Maite: RFL is starting the process by creating the statewide council which will have representatives from state agencies in the north and south which will assist us in aligning the goal of increasing high school graduation.
