- Ready For Life – Finished the High School Drop-out Prevention Summit, held November 8, 2010 at UNLV. Approximately 280 statewide people attended. The Statewide Council is up and running with a meeting scheduled in January 2011. The Evaluation Indicators have been approved and the Business Case has been implemented.
- YouthBuild – The program reported the total enrolled 67 with 29 completing the work experience and work readiness certificate.
- Junior Achievement – The Program is getting ready for the National Job Shadow Day.

- Nevadaworks – Not Present
- workforceCONNECTIONS – Collaborated with Urban League of Young Professionals for a Youth Summit in December 2010. Approximately 200 youth attended the conference which was held at UNLV. Wes Moore, author, was the keynote speaker.
- Nevada Department of Education - Mike Raponi reported that the Department of Education is currently working with Program of Study and a Plan of Study for Career and Technical Education that is providing a road map to start in the 9th grade and aligned with assessments and state standards.
- Nevada System of Higher Education – Edith Fernandez reported that NSHE will be releasing their first newsletter kicking off the GoToCollege.NV.com website. Also working with 16 local high schools to implement Navigation 101 which will be a program to teach career ready, college ready and will be a computer based program for students.
